Subject: Follow-up action on the Minutes of the 99<sup>th</sup> Meeting of the Executive Committee on Agenda Item No. 07 — for giving weightage towards CAS to the Orientation/Refresher Course designed by NCERT

The proposal for giving weightage for Orientation and Refresher Courses designed by NCERT while considering promotion of faculty under Career Advancement Scheme as similar to the UGC, approved courses vide Agenda Item No. 7, was approved by the Executive Committee of the Council in its 99<sup>th</sup> Meeting held on 03.12.2013. As a follow-up of the recommendations, it is hereby notified that the faculty who attend the Orientation-cum-Refresher Course organized by NCERT may use it as Orientation Course as well as Refresher Course depending upon their requirement for the purpose of promotion under CAS, as the case may be. Although the existing arrangement will continue, in future, the faculty members wish to attend the Refresher Courses organised by Academic Staff Colleges of UGC may also be permitted to meet their requirement for promotion under CAS.

It is reiterated that the instructions contained in the Council's Order No.F.1-6/2012/E-I/Pt. File No.2 dated 10/13-09-2013 may be adhered to by ensuring that the participation in Refresher Course is followed only after completion of the Orientation Course in the cases where faculty attend courses organised by Academic Staff Colleges of UGC.

This Notification shall take effect retrospectively from the date i.e. 23.09.2013 of organizing first Orientation-cum-Refresher Course by Department of Teacher Education, NCERT, Hqrs.
